#### Call before you dig!

We had the pleasure of having Susan Bohl, Executive Director with OKIE811 come and talk to us about "Calling before you dig". I learned so much about why you need to call before you dig. Even a simple project as putting in a fence up on your own vs. a company completing the service. If you don't call and have the lines marked in your yard and a buried line is cut or damaged, it could end up costing you thousands of dollars for the repair.

OKIE811 is a 501(c)(6) membership organization that was started in 1979. They service all of Oklahoma and are headquartered in Oklahoma City. Last year they had 1.1 million requests for the state of Oklahoma. 77% of the tickets submitted are by contractors completing work for clients/customers and the rest would be by the homeowner or owner of the property where the digging will occur. When they are digging, they have to watch out for what's called a tolerance zone and this is what they define as the horizontal space of 24" from the outside wall or edge of an underground line or pipe so they know its ok to dig around the marked line. If they need to dig within that zone you should not use automated or mechanical equipment.

If you've ever wondered what the different color of flags means when your yard is marked check out the list with the flag color and meaning.

Types and color of flags for underground lines are:

White – Proposed excavation Pink – Temporary Survey Red – Electric Yellow – Oil & Gas Orange – Telecomm Blue – Water

Blue – Water

Green – Sewer

Purple – Irrigation

Susan also had us guess what month the highest volume of calls is for them and it ended up being August. Then we guessed what the highest volume of ticket requests have been in the past year. We guessed oil & gas, Wind farm and new construction but our guesses were wrong. The number one ticket was for Fiber Optic Line in 2023. Susan also talked about the membership of OKIE811 and they consist of Municipalities, Pipeline, Rural water, sewer & gas districts and Telecommunications just to name a few of the main type of vendors.

So just remember the next time you have a project at your house and you need to dig don't forget to call OKIE811 to come out and mark the lines. One phone call can save you lots of money in case of a cut or damaged line!




